School of Police Staff and Command

Central Shenandoah Criminal Justice Training Academy in conjunction with Northwestern University will be offering the School of Police Staff and Command 10-week course starting January 28th, 2019.



The School of Police Staff and Command (SPSC) is an intensive ten-week program that prepares law enforcement managers for senior positions by uniquely combining academic principles with practical applications.

Since the program launched in 1983, the SPSC has received enthusiastic response from executives and participants throughout the country. In 2012, the program was redesigned and the course curriculum updated to better incorporate adult- and problem-based learning models.

In order to provide flexibility for departments, the revised School of Police Staff and Command is offered on-ground at locations throughout the U.S. and around the world and is also available online.

Member Agency Spotlight Continued

The Sheriff's Office is the primary law enforcement agency for Rockbridge County and works closely with the State Police, two city police departments (Buena Vista and Lexington), one college police department (Virginia Military Institute), a college public safety force (Washington & Lee) and a town sergeant (Glasgow). The Sheriff's Office employs a total staff of 43 personnel who serve in areas of patrol, investigations, civil and court services. Rockbridge County has 607 square miles and a total population of 36,300.



First elected in 2011, Sheriff Chris Blalock has focused on expanding and improving his agency's relationship with the community it serves. Most recently this past fall, we developed and launched two major community events that were held in rural areas of the county. The Sheriff's Party in the Park was held in Glasgow and the Sheriff's Fun at the Firehouse event was held in Goshen.

These two free community events brought hundreds of community members together to celebrate and fellowship with Sheriff Blalock and his staff. Community members were able to see a very clear picture of the services that the Sheriff's Office has to offer and provided a chance for the community to ask questions of our deputies and express their concerns regarding their neighborhoods. These block party type events helped build stronger relationships between the deputies and the community they serve.

Regional cooperation with the area's other police agencies is an important aspect of improving public safety. We are always looking for ways that we can work together to better serve our communities. For example, a shared 911 center was just implemented with a new county wide digital radio system and mobile data. Also, the Sheriff's Office is active in the regional drug task force and the Rockbridge Regional Citizen Police Academy. We feel jurisdictional boundaries shouldn't benefit those involved in criminal activity. By working more closely together, we can help ensure that they do not.

Lt. Campbell began his career at the Harrisonburg Police Department in 2001 as a patrol officer. He then transitioned to the JMU Police Department in 2003. He served as a Patrol Officer and Bike Patrol Officer for 10 years, during which he obtained instructor certifications in collapsible baton and defensive tactics, both of which Lt. Campbell teaches at the regional Police Academy frequently.

In April of 2013, Lt. Campbell was promoted to Patrol Sergeant and given the management responsibility of a squad of Patrol Officers.

In March of 2015, Lt. Campbell was given the assignment of Special Events and Crime Prevention Coordinator. During his time in this role, Lt. Campbell made many innovations to the program including a shared electronic calendar, graphical operations plans, and improved statistical analysis of personnel hours.

In September of 2016, he was promoted to Lieutenant and given command of the Police Department's Special Events Division.


