CSCJTA Begins the CALEA® Accreditation Process

On May 31, 2017 Interim Director Andrew McNally signed the agreement to start the CALEA Accreditation process. The academy has three Certified Accreditation Managers (Laurie Skinner, Lead Manager / Heather Gearheart / Matthew Bosserman) that will be working together to start the self-assessment process.

What this means for the academy and Member Agencies

The Public Safety Training Academy Accreditation Program has been in existence since 2002. The purpose is to promote superior public safety training services and recognize professional excellence. The program's standards tell the academies what they should be doing, but the decision on how it is executed is left up to the academy and the Chief Executive Officer.

CALEA Accreditation requires an academy to develop a comprehensive and uniform set of written directives. Being CALEA Accredited can limit the academy's liability and risk exposure because it demonstrates that recognized standards for public safety training academies have been met, as verified by a team of CALEA-trained assessors.

Member agencies will benefit from accreditation by the academy producing better trained public safety personnel and it will also promote greater accountability within the academy.

Timeline for accreditation

- Self-Assessment The academy has up to 2 years in self-assessment, but we intend to complete that early.
- Mock Assessment The academy has a CALEA certified assessor check their proofs and written directives pertaining to the required standards to make sure they're in compliance.
- On-Site Assessment CALEA certified assessors conduct the assessment and report their findings to the Commission for review and decision.
- Commission Review and Decision the Commission's Agency Review Committee conduct hearings, which are open for public attendance, regarding the academy's compliance to applicable standards. The final credentialing decision is made by the Commission and occurs at the next scheduled CALEA Conference.

MEMBER AGENCY SPOT-LIGHT

STAUNTON POLICE DEPARTMENT

The Staunton Police Department is located at 116 West Beverley Street in historic downtown Staunton, Virginia. The Staunton Police Department is charged with the duty and privilege of protecting and serving all persons within their jurisdiction.



he Staunton Police Department is led by Chief of Police Jim Williams. Williams, a 32 year veteran of the Department, has served as the police chief since July 1, 2003. Chief Williams is a proponent of community policing and fair and impartial policing. The Department conducts numerous community outreach programs, including Kid's Matter Day, Shop with a Cop, Coffee with a Cop, Special Olympics Torch Run, Cone with a Cop, Neighborhood and Business Watch, Citizen's Police Academy, and many others. In addition, the Staunton Police Department was among the first agencies in Virginia to adopt the fair and impartial policing model, serving as a host agency for the training in 2016.


The Staunton Police Department is a full-service police agency, providing a wide range of law enforcement and related services to the members of the City of Staunton and its visitors. The Department consists of 52 sworn officers and 18 full-time civilian employees. The Department maintains a part-time tactical team, bicycle patrol, school resource officers, crime analysis, reserve police, honor guard, K-9, school crossing guards, CIT officers, parking enforcement, records/evidence and participates in the regional Skyline drug and anti-gang task force.

In addition to providing 24 hour patrol coverage and criminal investigation functions, the Department also houses the city's state-of-the-art Enhanced 911 Center. The center serves as the primary answering point for 911 emergency calls for service and dispatches for police, the fire department, and the local rescue squad.


In May of 1985, the Staunton Police Department became one of the first agencies accredited by the Commission on Accreditation for Law enforcement Agencies, Inc. (CALEA). The Department has since received re-accreditation awards in 1990, 1995, 1998, 2001, 2004, 2007, 2010, 2013 and 2016. The Department is the longest tenured agency in the world, having received 10 accreditation awards, including recognition as both a CALEA flagship agency and meritorious accreditation.
