Sheriff Eric Hess

The Fluvanna County Sheriff's Office is full-service law enforcement agency that provides primary law enforcement services for a population of approximately 27,000 people. Fluvanna County is a beautiful, mostly rural, 288 square mile county located in Central Virginia.

The Sheriff's Office is led by Sheriff Eric B. Hess who has committed to providing community-oriented, best in class law enforcement services to all persons in Fluvanna County by providing a well-trained, involved, and empathetic team willing to take on and overcome the challenges of modern policing.

Sheriff Hess has served the last 7 years as Sheriff, he previously held the position of Chief Deputy from 2008 to 2014. To achieve his goal of providing efficient and effective law enforcement services to the people of Fluvanna, the Sheriff's Office is broken down into three divisions: Field Operations, Communications and Technology, and Judicial Operations. A dedicated team of 58 deputies, communications officers, and civilians help keep the people and daily visitors of Fluvanna safe 24 hours a day, 7 days a week.

Field Operations is responsible for 24-hour patrol and response coverage, criminal investigations, animal care and control, and a twenty-five-member Reserve Deputy Unit. The Investigations Unit also maintains a computer forensic lab and is an active participant on the Internet Crimes Against Children Taskforce.

Communications and Technology operates the Emergency 9-1-1 center which answers and dispatches all law enforcement, fire, and rescue calls for service in the county. They also maintain the agencies radio, computer, communications, and records management systems.

Judicial Operations provides court security, inmate transportation, civil process, and school resource officer coverage, oversees the VIPS and TRIAD programs, as well as the agencies evidence room.

Sheriff Hess has embraced technology and all patrol vehicles are equipped with mobile data terminals and in car camera systems. Additionally, all patrol deputies wear body worn cameras that are linked to the vehicle camera system to provide complete coverage on calls for service to better ensure transparency and accountability.

Additional programs the Sheriff's Office has implemented are D.A.R.E, Child ID, Community Crime Prevention, a training team to ensure in-house training is constantly improving, specialized crime-scene investigators, an arson investigator, partnering with Shelter For Help In Emergency to conduct Lethality Assessments to try to break the cycle of Domestic Violence, participation in a Multidisciplinary Team to take a coordinated approach to child abuse and sexual assault investigations, Project Life Saver, and full membership in the Virginia Sheriff's Association.

Page County Emergency Communications Center

Page County, Virginia, a tourist community, is home to the Luray Caverns, which has approximately 500,000 visitors each year from all around the world. The County also offers hiking, the Shenandoah River and access to the Skyline Drive.

In 2013, the Page County Emergency Communications Center received its new home on the top floor of the County Administration building in Luray. A center staffed with twelve full time employees and five part time employees, Page County ECC handles fire and rescue dispatching for three volunteer fire departments, three volunteer rescue squads, and County career staff. The center also dispatches emergency and non-emergency calls for the Page County Sheriff's Office and three town police departments: Luray, Stanley and Shenandoah, and is under the direction of the Page County Emergency Services Department and is led by an ECC Manager and 2 shift supervisors. Servicing a County of 24,000 residents, Page County ECC answered over 11,000 emergency and non-emergency calls last year (2020).

Page County ECC houses many seasoned employees; with one employee dedicating 29 years of service to our community. An array of certifications is also present in the Center, ranging from General Instructors to Peer Support. Training is very important in the Center and all employees are encouraged to train, when possible.

In an effort to engage employees and boast moral, each year the Center votes on a "Dispatcher of the Year". This person receives a plaque and is recognized at the Board of Supervisors meeting. The award for 2020 was awarded to Mary Cubbage, a recent graduate of CSCJTA Basic Communications Officer course.



He transferred to HPD in JAN 1998 and completed a total of 12 years as a Patrol Officer. During this time, he left HPD for a couple of years to work as a Protective Security Specialist for the US Depart-

ment of State in Baghdad, Iraq (2004/2006), where he was a member of the close protection team for the US Ambassador to Iraq. He also spent 16 years as a member of HPD's SWAT Team.

Beginning in 2012, he became a full-time training officer in HPD's Personnel Development Unit where he specializes in weapons and tactics training while conducting or coordinating numerous annual training events for the Department's 112 sworn officers. He holds DCJS instructor certifications in General Instruction and Firearms. He also is certified as a TASER Master Instructor, Patrol Rifle instructor, ASP Baton Instructor, among others. This year will mark 21 years of law enforcement service for him.

Chris is active with the Academy as a Firearms Instructor, currently serving as the Lead Instructor for the BLE range sessions, Firearms Instructor Development Schools, and Pistol Marksmanship/Combat Pistol Classes. He enjoys spending his free time with his wife, Tara, and their Chocolate Lab, Digger.
